Welland Hydro-Electric System Corp. (WHESC) is pleased to forward to you an *Offer to Connect* with respect to your net metering system.

**Metering:** The net metering system will require the installation of one additional meter which will be a bi-directional meter. You will be responsible for providing the appropriate meter base for the installation of the meter at a location agreed to by our staff. WHESC will provide and install the meter once *Authorization to Connect* is received from the Electrical Safety Authority, connection costs are paid and a *Net Metering Connection Agreement* is signed.

**Disconnect:** A lockable disconnect switch located next to the generator meter is required. The disconnect switch must be made available at all times for WHESC staff use in isolating the supply of energy. The disconnect switch and installation are required to meet the Ontario Electrical Code and will be inspected by the Electrical Safety Authority.

**Connection Cost:** The connection cost for WHESC to connect your net metering system is \$\_\_\_\_\_ plus HST. This cost includes one (1) trip by our staff to disconnect the service to the generation facility, one (1) bi-directional meter and one (1) trip by our staff to reconnect the service at the generation facility. Any additional costs outside of the aforementioned items will be charged separately if applicable.

**Net Metering Connection Agreement:** A signed *Net Metering Connection Agreement* is to be returned to WHESC if a copy has not already been submitted. The *Net Metering Connection Agreement* sets out technical standards associated with the installation and general conditions of service.

**Offer to Connect:** Please return a copy of this *Offer to Connect* to the undersigned to confirm your agreement with the costs and schedules as outlined.
